This brief analysis is drawn from the results of the samples in the preceding pages.

68% of Canadian samples and 62% of US samples had glyphosate. These figures keep oscillating as more data is entered, but the trend is now beginning to emerge - around two thirds of all samples contain glyphosate.

Next, 54% of organic foods had glyphosate, as had 79% of non-organic foods. These figures might indicate how hard it would be to avoid getting glyphosate if you live and eat in North America.

However, a closer look will show that the average glyphosate content of Organic food is 18.3 ppb (parts per billion) whereas average glyphosate content in non-Organic food is just over 171 ppb, an almost ten fold increase.

Although the sample is small, Asian foods tend to be cleaner than North American ones. Waiting for more data from Europe, Africa and South America.

In other words, while it is tough avoiding glyphosate in north America if you do not grow your own food, eating organic rather

than non-organic foods bought from stores greatly reduces your glyphosate intake.

I intend to put more of such analysis out for the people, such as how much of glyphosate is present on average in, say, wheat, or oranges, or soy products, or gluten free stuff etc.
