Subject: **BC should independently verify threat posed by covid19**

To: Honourable Premier John Horgan,

I as a Canadian citizen and resident of British Columbia am greatly concerned that the current restriction to normal economic and social activity, based on fear of a variant of the flu virus. In this context urge you to consider the following, which are my views but would merit independent verification:

- * Coronavirus is a generic name for a virus family that has been around inducing influenza in some people every year for a long time. Most of us have been exposed to some variant of it in the past. Our immune system usually deals with it without much fuss. Only some elderly and immunocompromised people have trouble, and should be the ones protected.
- * Today's Covid19 deaths, combined with the rest of the flu infected deaths are not outside of the range of seasonal variations in flu deaths of past years.
- * Viruses mutate rapidly and their RNA can alter day by day or even hour by hour. There is no real proof that the tests being conducted for a tiny fragment of RNA to identify Coronavirus infection are relevant.
- * Despite whatever today's modern science claims - no virus, let alone a coronavirus, has successfully been isolated (from other genetic debris), purified, and its entire genome properly sequenced, and then the virus reintroduced into a test animal to reproduce the same illness as found in supposed covid19 patients. Modern science has instead been shifting the goalposts to get around time tested postulates and gold standard practices. Science may be losing its original neutrality, objectivity and purity.
- * Many independent medical professionals that are not paid by the Government or industry and are able and willing to do honest unbiased science have already said social distancing and lockdowns are exactly the wrong thing to do if you want quick herd immunity.
- * I am attaching a partial table created by me from WHO's own websites on declaration of financial contributions to it annually by state actors and non state actors. You will notice the extraordinary size of contributions from the Bill Gates Foundation as well as channels under control of the Gates family such as Gavi Alliance.
