M.R. (Measles-Rubella) VACCINATION:

Parents have the right have knowledge and then give consent

As per newspaper reports, in India 41 crores children are going to be vaccinated within 1-2 years and in Punjab 75 lac children are going to be vaccinated within 1-2 months. This injection is to be given to all children between the ages of 9 months to 15 years. Whenever a doctor or hospital undertakes a medical procedure which can cause injury or death, there should be an informed consent from the person in case of adult or parents in case of a child. Informed Consent means person/parent be explained the benefits and possible risks of the procedure. Any procedure be undertaken after the informed consent has been given.

The parents should have the following information regarding MR Vaccination.

- 1. Measles Vaccination is being given to every child since 1985. At that time parents were told that this one injection will save their child from Measles throughout his life.
- 2. After some years it was found that the assurance was not true and child suffers from Measles at a bit later age in spite of the vaccination.
- 3. Second dose was started in 2010 in the form of MMR (Measles, Mumps and Rubella) at the age of about 15 months. The parents were told that their child will be free of three diseases (Measles, Mumps and Rubella) for rest of their life after this vaccination.
- 4. This assurance was again proved wrong. Children were still suffering from measles though at a still older age. Same was true about Mumps. Nothing can be said about Rubella because it is such a mild disease that many a times even the sufferer does not know about its occurrence.
- 5. All children who are being vaccinated with MR have already received above two doses. Now they are being asked to have an additional dose.
- 6. Now Mumps has been silently dropped-MMR has become MR and it is being claimed that this vaccination will eradicate Measles and Rubella. Close scrutiny reveals that Mumps virus has mutated to a new strain and Mumps component of MMR has become useless.
- 7. This is an historical fact that Manufacturers, Doctors and Government Institutions hide lots of facts about vaccines from the parents. People are daily facing this grave problem in the hospitals in other aspects of treatment also. There is no transparency in the prescription of medicines and vaccines. To escape this deception, parents have formed their own organizations in western countries. For example in USA there is an organization under the name "FEARLESS PARENTS". These organizations undertake independent research, have their websites and use other ways to share their research with other parents. They give consent for particular vaccine to their children on the basis of their own research. Such like organisations of parents should also be formed in our state so that parents become knowledgeable and take correct decisions.
- 8. A vaccine hysteria has been created by the vested interests based on Fear. It is being projected that hell will fall on the head of their child if he or she is not vaccinated with this vaccine.
- 9. They are shouting at the top of their voice that danger is so great that we don't need to follow ethics -Vaccinate without any consent-

informed or uninformed ,needs compulsory vaccination, need a law for compulsory vaccination, No exemptions for anyone etc. etc.

- 10. Jargon of misquoted statistics is flashed to horrify the parents. Horrified parents give their consent for vaccination. That way the number of vaccines has crossed 20. Parents are being convinced that more the number of vaccines more healthy will be their child. This has been proved to be an absolute lie in many studies.
- 11. Manufacturers give huge incentives to doctors and sellers to be propagators of vaccines. They inflate the serious risks and entice the parents to have all the available vaccinations.
- 12. There are law suits against the manufacturer of mumps vaccine (which is also the sole provider of MMR vaccine in the U.S.) alleging the company of going to illegal lengths to hide the vaccine's ineffectiveness.
- 13. There are law suits against the manufacturer of MMR for falsely claiming MMR to be safe vaccine. When the fact is that it is not a safe vaccine.
- 14. Now Mumps has been silently removed from MMR and MR has been projected as some new revolution for children. Mumps virus has mutated to a changed strain and Mumps Vaccine is no more effective. That is precisely the reason they have silently dropped Mumps and have come up with MR Vaccine i.e. Measles and Rubella. MMR Vaccine has earned quite a notoriety of causing brain damage and autism. By changing the name they are trying to wash the notoriety of MMR.
- 15. Now it is being said that child needs multiple doses of MR Vaccine to have lifelong immunity.
- 16.In USA which started Measles, Mumps and Rubella much earlier than India, have failed to stop the occurrence of Measles and Mumps.
- 17. Rubella is such a mild disease that it goes unnoticed frequently-not much can be said about it.
- 18. Why Rubella Vaccine for boys? Is there any logic? Rubella is a very mild disease. Its vaccination is justified only in females on the premise that infection with rubella virus can cause damage to the fetus during first three months of pregnancy. That also is justified near the marriage. The immunity of rubella vaccine is likely to be stay only for few years. How immunizing young school going girls is justified?
- 19. Measles Vaccine Virus is live virus-it has been proved that this virus can travel directly to the brain through nerves particularly in a state of compromised immunity. The Merck Manual acknowledges that vaccines can cause brain damage: Encephalitis is inflammation of the brain that occurs when a virus directly infects the brain or when a virus, vaccine, or

- something else triggers inflammation. The spinal cord may also be involved, resulting in a disorder called encephalomyelitis.
- 20. Vaccine affectivity has been repeatedly questioned. The claims that mass vaccination of the population leads to sustained herd immunity has been proved to be a myth. The fact is, vaccine-acquired artificial immunity does not work the same way as the naturally acquired longer-lasting immunity you get after recovering from the disease. As a result childhood diseases are becoming diseases of adulthood.

Barbara Loe Fisher, co-founder and president of the National Vaccine Information Center (NVIC) of USA has clearly said- "Vaccines do not confer the same type of immunity that natural exposure to the disease does ... Vaccines only confer temporary protection... In most cases natural exposure to disease would give you a longer-lasting, more robust, qualitatively superior immunity because it gives you both cell mediated immunity and humoral immunity. Humoral is the antibody production. The way you measure vaccine-induced immunity is by how high the antibody titers are. (How many antibodies you have.) The problem is, the cell mediated immunity is very important as well. Most vaccines evade cell mediated immunity and go straight for the antibodies, which is only one part of immunity."

21.Be Aware of MMR Vaccine Risks

If a vaccine is indeed highly effective, and avoiding the disease in question is worth the risk of the potential side effects from the vaccine, then many people would conclude that the vaccine's benefits outweigh the risks. They may even be in favor of an additional dose. However, if the vaccine is ineffective, and/or if the disease doesn't pose a great threat to begin with, then the vaccine may pose an unacceptable risk. This is particularly true if the vaccine has been linked to serious side effects. Unfortunately, that's the case with the MMR vaccine, which has been linked to thousands of serious adverse events and hundreds of deaths.

According to National Vaccine Information Center (NVIC) of USA:-

"As of March 1, 2018, there had been 1,060 claims filed in the federal Vaccine Injury Compensation Program for injuries and deaths following MMR or MMR-Varicella (MMRV) vaccinations ... Using the MedAlerts search engine, as of February 4, 2018, there had been 88,437 adverse events reported to the Vaccine Adverse Events Reporting System (VAERS) in connection with MMR or MMRV vaccines since 1990.

Over half of those MMR and MMRV vaccine-related adverse events occurred in babies and young children 6 years old and under. Of the MMR and MMRV vaccine related adverse events reported to VAERS, 403 were deaths, with over 60 percent of the deaths occurring in children under 3 years of age." Keep in mind that less than 10 percent of vaccine adverse events are ever reported to VAERS. According to some estimates, only about 1 percent are ever reported, so all of these numbers likely vastly underestimate the true harm.

22. Protect Your Right to Informed Consent and your right to choose.

With all the uncertainty surrounding the safety and efficacy of vaccines, it's critical to protect your right to make independent health choices and exercise voluntary informed consent to vaccination.

23.Medical Research has virtually been hijacked by the vested interests.

Research is oriented to their business interests rather than common good. This fact has been documented time and again. For example see a quote from a recent article in Wall Street Journal by Peter Wood and David Randall-How Bad Is the Government's Science?

"Policy makers often cite research to justify their rules, but many of those studies wouldn't replicate."... "Half the results published in peer-reviewed scientific journals are probably wrong. John loannidis, now a professor of medicine at Stanford, made headlines with that claim in 2005. Since then, researchers have confirmed his skepticism by trying—and often failing—to reproduce many influential journal articles. Slowly, scientists are internalizing the lessons of this irreproducibility crisis. But what about government, which has been making policy for generations without confirming that the science behind it is valid?"

- 24. Measles is not a serious disease for healthy children. As the parents are getting informed truly in western countries, they encourage their children to go and play with the neighbor child suffering from Measles rather than stopping him. They know that for a healthy child Measles is not a serious disease and will give lifelong immunity.
- 25. Measles Scenario in USA-

- CDC reports that no one in the US has died of measles in the last 12 years. Meanwhile, 98 measles vaccine related deaths were reported to the US government since 2003.
- During that time period, 694 measles vaccine-related disabilities were reported to the Vaccine Adverse Reporting System (VAERS).
- Child mortality due to measles is 200 to 400 times greater in malnourished children in less developed countries than those in developed ones; as nutrition improves, complications and deaths radically diminish. For a healthy child measles is not a serious disease.
 - 26.Entire humanity is being convinced through false propaganda that getting the entire population to accept the concept that vaccination is a more effective way to stay healthy. The truth however is that supporting your inborn immunity and optimizing immune function, is so essential to preventing illness and serious complications from infectious diseases.
 - 27. Throughout the 1800s, measles epidemics occurred about every two years in the United States and England. During these epidemics, when suboptimal sanitation and nutrition were the norm, some hospital wards overflowed with children with measles and up to 20 percent died from pneumonia and other complications. However, by the 1960s, deaths from measles had dropped to extremely low numbers in both England and the United States. In England, the percent decline from its peak level reached an astonishing 99.96 percent by the time the live attenuated measles virus vaccine was introduced in 1968. So it is very clear that deaths because of measles were almost eliminated before the introduction of measles vaccine. We need to keep this in perspective. These were deaths BEFORE the launch of measles vaccines in the 1960s, when deaths from asthma were 56 times greater, accidents 935 times greater, motor vehicle accidents 323 times greater, other accidents 612 times greater, and heart disease 9,560 times greater. Why such a disproportionate emphasis on measles deaths?

These are some points which parents should know before taking a decision whether to get their child vaccinated or not. Nut shell we must examine three aspects-

- 1. How serious is the disease against which vaccine is to be used? The disease should be serious enough to cause death or disability.
- 2. How effective is the vaccine? The vaccine should be quite effective with almost 100% protection for a long period.

3. How safe is the vaccine? Vaccine should be reasonably safe. It should not cause death or disability.

Earlier MMR which has now been brought as MR does not fulfill all the three criteria. If these criteria are not fulfilled we should not resort to vaccinations which usually have serious side effects. There are lots of other milder methods of increasing immunity-good diet, home remedies, herbal medicines and allopathic drugs including food supplements which are 100% effective in treating such illnesses without any permanent disability or death.
